


What is Unstructured Sharing in Microsoft365?

- External Sharing in Microsoft 365 strongly supports ad-hoc collaboration
- Unstructured sharing involves sharing documents with a few to a few dozen external people
- Secure Link sharing to sites, libraries, and documents











Microsoft 365 Native External Sharing



Microsoft 365 Tools for Unstructured Sharing



Request Files with OneDrive for Business


- Ask colleagues and external users to upload files to a folder
- Uploaders can only see their own content





Shareable Links in SharePoint Online

- Enable edit and/or read access to colleagues or external users
- Can modify granularity of access






Teams Shared Channels


 Invite anyone allowed in the host organization's tenant, including external



Teams Shared Channels

- Collaborate seamlessly across team and organization boundaries:
 - No tenant switching
 - Share only what needs to be shared
 - Reduce team proliferation
- External users can be added to Shared Channels without being guests in the host tenant








Invite External Users into your Microsoft 365 with Azure AD/Entra

- Restricted to IT personnel with Azure privileges
- Highly manual: users invited one at a time, or bulk import
- User Guest Inviters have limited capabilities
- Azure AD B2B allows guests to login and access apps and resources in Microsoft 365
- Supported onboarding experiences:
 - Microsoft account via SSO
 - Non-Microsoft account via One-Time Passcode authentication
 - Social users via SSO (with federation)

External Sharing Challenges in Legal/Professional Services



Confidentiality Breaches and Access Control

Need granular permissions structure for files subject to NDA or Intellectual Property (IP) Protection



Audit Trails

Need audit logs of who accessed/modified documents

• Complex with external users



Document Retention and Archiving

Disparate systems used for research and documentation

 Can make externally sharing, coauthoring and retrieving files inefficient



Mergers and Acquisitions

Integration of IT systems

• Data migration and handling sensitive documents



External Sharing Challenges in the Financial Sector



Regulatory Compliance and Data Sovereignty

Typically operate under stringent regulations (GDPR, CCPA, GLBA, PCI)

Varies geographically



Data Loss Prevention (DLP)

Ensuring sensitive data doesn't get leaked when collaborating externally is challenging

• DLP tools are complex to configure and monitor



Identity Verification



Real-Time Collaboration

Financial markets move quickly; realtime collaboration often necessary

•Can become inefficient with external parties



ernal Sharing Challenges in Healthcare



Data Privacy and Protection

Personal health information (PHI) and patient confidentiality

- Differing data privacy regulations across the globe
- Shared data must comply with international, national and local regulatory standards



Data integrity and accuracy/version control

Changes made by external collaborators may not be tracked

• Potential for inconsistencies



System incompatibilities

Disparate systems used for research and documentation

• Can make externally sharing, co-authoring and retrieving files inefficient



Structured Sharing with Microsoft 365

- Typically hundreds to hundreds of thousands of external users
- Represent many different groups of external users
 - Projects
 - Committees
 - Customers/Partners/Vendors
- May have many different business owners
 - Owners can be internal or external




